

PERDUE SEA CREATURE CHICKEN NUGGETS SWEEPSTAKES

OFFICIAL RULES

1. Entry Period: The Perdue Sea Creature Chicken Nuggets Sweepstakes (the "Sweepstakes") begins at 9:00 a.m. ET on 07/20/2025 and ends at 11:59 p.m. ET on 07/26/2025 ("Sweepstakes Period"). Sponsor's computer is the official time keeping device for this Sweepstakes.

2. Sponsor: The Sponsor of this Sweepstakes is Perdue Foods, LLC, P.O. Box 1537, Salisbury, MD 21802 ("Sponsor").

3. Winner Notification Date: The potential winners will be notified on or about 07/27/2025.

4. Eligibility: The Sweepstakes is open only to legal residents of the fifty (50) United States and the District of Columbia who are eighteen (18) years of age (19 in Alabama and Nebraska; 21 in Mississippi) or older at the time of entry. Officers, directors, and employees of Perdue Foods, LLC and their respective parents, subsidiaries, representatives, contractors, consultants, mandatories, affiliated companies, franchisees, advertising and promotional agencies, legal counsel, website providers, webmasters, persons engaged in the development, production or distribution of materials for this Sweepstakes, and their immediate family members (parent, child, sibling, and spouse of each) and/or persons living in the same household as such officers, directors, and employees (whether related or not) are not eligible to enter or win a prize in this Sweepstakes. Entry into this Sweepstakes constitutes entrant's full and unconditional

agreement to these Official Rules and to Sponsor's decisions, which are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein.

Upon completing these steps, you will be automatically entered with one (1) entry into the Sweepstakes. If you do not have an Instagram account, you may create one for free by downloading the free Instagram mobile application and following the on-screen instructions. Ensure that your Instagram account settings allow the Perdue Instagram page to contact you via direct messaging in the event you are selected as a potential winner.

By entering in this Sweepstakes, you signify and agree that your Entry and any other materials submitted in connection with this Sweepstakes may be posted on Sponsor's website and/or other social media sites or applications associated with the Sweepstakes

in a manner that is consistent with these Official Rules. The odds of winning are based on the number of eligible Entries received per Entry method. Two (2) winners will be selected for this Sweepstakes, in total.

The potential winners will be notified on or about 07/27/2025 via direct message ("DM") to his or her Facebook or Instagram account (as applicable), and will be required to respond within three (3) business days of such notification.
